

San Diego County High School Mock Trial Competition Naming Rule

All participants including active team members, substitute team members, coaches, teachers, judges, scorers, and monitors must follow the naming rule to be admitted into each round of the virtual competition. Teams will be identified by team code only and not by school name. Only the participants listed above will be admitted into the virtual competition.

Active team members, substitute team members, teachers, and coaches will create their mock trial display name as follows: **(Trial #) Team Code (P/D) Participant First and Last Name (Role)**. Below are examples of how the mock trial display name must be formed. These are just examples, please use your information when forming your mock trial competition display name.

How to Change your Zoom Display Name:

Option 1- If you have a Zoom account and you are using the Zoom app: To change your name **using the desktop app, click on the gear icon in the top right-hand corner, click on Profile, click on Edit My Profile, and click on the blue edit option to the right of your current display name.** To change the display name, select the corresponding box and type in your mock trial competition display name.

Option 2- If you have a Zoom account and you are using Zoom in a browser: To change your display name **using a web browser, go to Zoom.us and sign into your account and click on Profile in the left side menu.** Click on the blue edit option to the right of your current display name. To change the display name, select the corresponding box and type in your mock trial competition display name.

Option 3- To change your display name **after entering a Zoom event/meeting, click on the Participants button at the top of the Zoom window.** Next, hover your mouse over your name in the Participants list on the right side of the Zoom window. Click on Rename and enter your mock trial competition display name and click OK.
